PRIVACY POLICY

This privacy policy governs the use of the software application Антирадар М. Радар детектор. (the "App"), which package is "com.macsoftex.antiradar.free", that was created by Macsoftex Company (the "Company"). The App is basically a map or radar that shows and warns about the road dangers of an internal database and the road dangers submitted by the other users of the App in real time.

Using information obtained by the App

User provided information

The App will collect your Device ID, app Version, language, country and push id. Registered users agree to associate all the previous data to user's accaount. When a road danger is added the App send to an online database your device ID, location, type, name and time of this point to ley you see, modify and delete it in future uses of the app. This points will be shown in other users map of the app and they will be able to vote them and the Company have the rights to commercialize them.

Automatically collected information

In addition, the App may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, your mobile operating system and information about the way you use the App.

The App may use, when activated the mobility function (Find My Car), access to battery consumption, Wifi and Bluetooth systems connectivity data, type of device, location, operating system, sensory input and system crash information. This data will be collecting and the features used to do so, including that such information may be collected even when the App or is shut down.

Collecting precise real time location information of the device

The App use the GPS technology to track your position for timely warning about road dangers.

The App can also collect precise location data even when the app is off, in case the mobility service (Find My Car function) is activated.

Accuracy of information and responsibility

All the users in real time provide the road dangers locations. The Company combine the information and update the database with road dangers. However, the Company cannot assure the validity of the information (road dangers) and the users must use them by their own responsibility.

The Company is not responsible for any consequence due to the incorrect description or information in the App. The users must be use it by their own risk taking in mind that some road dangers could not be in the database.

- to the companies in charge of SDK used by the App.

We reserve the right to commercialize and distribute the data collected by the App.

Automatic Data Collection

We may work with analytics companies to help us understand how the App is being used, such as the frequency and duration of usage.

Opt-out rights

There are several opt-out options for users of this Application: Opt-out of all information collection by uninstalling the App: You can stop all collection of information by the App easily by uninstalling the App. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

Managing Your Information

The SDK will be enabled by default or from the first time the user accepts the access to the device location. The SDK can be activated and deactivated from inside the application, under the Settings menu.

For the correct work, personal and/or sensitive information (including battery consumption, Wifi and Bluetooth systems connectivity data, type of device, location, operating system, sensory input and system crash information) will be collected by the App and SDK, and the features used to do so, even when the application is shut down.

The information collected may be used by the Company and/or third parties for their own uses including commercialization of such information. The user can at any time turn off this function under the Settings menu.
